## Section A: Native Americans, West of the Mississippi, 1840–1890

Study the Background Information below and then answer **all** the questions. Use your knowledge to help you interpret and evaluate the sources, as appropriate.

#### Background Information

Native American society was communal and tribal. Tribes competed with, and sometimes fought against, each other. Despite their differences, most Native Americans shared common values and organized their lives in similar ways. Most white men did not share these values and the majority failed to understand or appreciate Native American society.

#### Part A: Native American Society

You are advised to spend 1 hour answering Questions 1 to 4.

**1**. Study Source A.

In what ways was the horse important to Native Americans on the plains? Explain your answer using details from the source **and** your knowledge. [6]

2. Study Source B.

Does this account support the view that the religious practices of Native Americans were "barbaric"? Explain your answer using details from the source **and** your knowledge. [7]

**3**. Study Source C.

How reliable is this source about the care of the weak and needy in Native American society? Explain your answer using details from the source **and** your knowledge. [7]

4. Study Sources D and E.

Is one of these sources more useful than the other as evidence of the attitude of Native Americans to the land? Explain your answer using details from the sources **and** your knowledge. [10]

#### Part B: White Attitudes to Native Americans

You are advised to spend 30 minutes on your answer.

5. Study Source F.

Does this source confirm that white men were completely intolerant in their attitude to Native Americans? Use the source **and** your knowledge to explain your answer.

In addition to Source F, you may use any of Sources A to E to help you answer this question. [15]

# Section B: The Presidency of Harry S. Truman, 1945–1953: Domestic and Foreign Policy

Study the Background Information below and then answer **all** the questions. Use your knowledge to help you interpret and evaluate the sources, as appropriate.

#### Background Information

Truman faced enormous problems at home and abroad. His presidency was also a period of considerable opportunity. Truman attempted to tackle economic and social issues in the U.S. by building on the New Deal. He provided leadership to the free world by supporting the United Nations and by helping the development of poor countries.

#### Part A: Post-War Recovery

You are advised to spend 1 hour answering Questions 6 to 9.

6. Study Source G.

What is the message of this cartoon? Explain your answer using details from the source **and** your knowledge. [6]

7. Study Source H.

Does this Act indicate that Congress favored businessmen rather than workers? Explain your answer using details from the source **and** your knowledge. [7]

8. Study Source I.

How useful is this source about Truman's attitude toward African Americans? Explain your answer using details from the source **and** your knowledge. [7]

9. Study Sources J and K.

Is one of these sources more useful than the other as evidence about the U.S. economy during the Truman presidency? Explain your answer using details from the sources **and** your knowledge.[10]

## Part B: Truman's Foreign Policy Aims

You are advised to spend 30 minutes on your answer.

**10**. Study Sources L and M.

To what extent did Truman's foreign policy aim only to promote U.S. economic interests? Use the sources **and** your knowledge to explain your answer.

In addition to Sources L and M, you may use any of Sources G to K to help you answer this question. [15]
